REPORTS

1. Chairman (Peter Brown)

The Chairman referred back to the item referenced in Matters Arising and his open letter to clubs, where it was noted that there had been an improvement in behaviours for one month and then unfortunately both on field and off field discipline matters had returned to their

previous levels which was disappointing to note. Clubs were urged to take responsibility fot the behaviour of their players, spectators and officials to avoid a worsening of disciplinary matters and the match day experience for those participating.

2. General Secretary (Jonathan Brown)

a. <u>Divisional Move Requests</u>

The General Secretary advised that there had been a further number of requests from teams to have their divisional position adjusted within the constitution. The requests are listed below, with the decision ratified and confirmed by the Committee.

- Potton United Youth Royals (Under 14) requested to move down to Under 14, Division 4 from Division 3 – initially rejected, but following further defeats and review, was accepted.
- ii. Sundon Athletic Youth (Under 11) moved up from Under 11 Development Groups to Under 12, Division 1 at request of CYFL Committee – thanks were recorded to the team for their support and consideration in this matter to ensure that the team are playing at the correct level for their ability
- iii. Shortstown Rangers Dolphins (Under 12) request from CYFL to move up to Division 3 from Division 4 based on early results in the season this request was rejected by the team with the reasoning being accepted by the CYFL Committee

b. England Accreditation

The General Secretary advised that Mrs Vase was taking the lead in the renewal of the League's England Accreditation and the Committee were updated as to the current progress.

As part of the renewal process, Mrs Vase updated the Committee on some areas of compliance for Committee Members and it was agreed upon some best practice that the Committee would be following moving forwards.

Mrs Vase also advised the Committee that both her and Mr Thomas (CWO) had attended one of the recent club Accreditation Evenings that had been hosted by the Bedfordshire Football Association. This event focused on those clubs who were not England Accredited or require support as part of the renewal process. Mrs Vase advised that the session had been extremely valuable and as a league, the CYFL were to only one represented at the meeting. Following the meeting, Mrs Vase had surveyed all the clubs who were not Accredited to offer support through the process.

The Committee thanked both Mrs Vase and Mr Thomas for their time in attending the meeting and the good work being undertaken in this area.

c. RESPECT Barriers Update

RULE 20(M) REFERENCE NRB003

The General Secretary advised that on their whole, the vast majority of games so far this season had been played in accordance with league rules and with RESPECT Barriers in place. However a couple of examples had been reported where barriers were not in place and it was agreed that the following teams should be fined for a breach of League Rules as per the below;-

d. RESPECT Mark Audit

The Committee reviewed a document which contained the RESPECT Marks that had been awarded by and to all members teams during the first 2 months of the season. (Please see separate document attached)

A discussion took place regarding the RESPECT Marks and potential next steps regarding those teams who had not scored highly in the opening months. It was agreed that the General Secretary would contact those teams requiring action to discuss plans further.

Please note a separate document will be circulated to all clubs containing further details for review and consideration.

3. Fixture Secretary (Tony Gee)

I his absence, Mr Gee had submitted the following report -

a. Fixture Updates

League fixtures are okay (although bad weather of Sunday 5th November caused a few postponements and re-scheduled County Cup fixtures). However, the majority of divisions were progressing well with no issues to report at this stage.

b. County Cups

Mr Gee advised that he was not impressed with the current position of the Bedfordshire Football Association County Cup fixtures

An additional round of games had been scheduled which had not previously been advised upon, meaning that the CYFL fixtures that had been scheduled required adjustment. It was noted that the League had still not received a full draw scheduled for all Sunday Youth Competitions for the coming season, so were working a little in the dark at times in this area.

4. Players Registrations Secretary (Emma Vase)

These transfers were approved by the Management Committee.

Mrs Vase advised that there were very little issues to report at this stage of the season and things were progressing nicely with regards to player registrations.

It was noted that presently, as well as an entire girls team participating in the Under 13 age group, there were a total of 57 girls registered in the CYFL, which equates to 1.69% of total players registered.

It was also noted that earlier in the season a game had been played between two teams in the CYFL, one of which had boy triplets playing for them, while the opposition had girl triplets playing for them. The Committee noted the unusual nature of this and that both teams had reported the facts on social media.

Mr. Cooper advised that he continued to be pleased with the coverage that he had been able to achieve in the first 2 months of the season, through a mixture of his hard work and also the availability being offered by the match referees in supporting him and the League.

Bedfordshire County Cup fixtures have now started and will impact the allocation on those Sundays where County Cup fixtures take priority over CYFL fixtures.

A further cohort of newly trained match referees from the training course in October had now started to be appointed to games and it was hoped that they would have a long and successful refereeing career, hopefully the the CYFL and that the member clubs would look after and support the new officials.

5. Treasurer (Jane Brown / Nicholas Brown)

The Assistant Treasurer advised that he had now completed the move of League monies to a new Bank Account to get a better interest rate.

So far fines have been mostly paid on time and those clubs who were paying in a timely manner were thanked for their support.

Unfortunately, a number of payments had been received WITHOUT the appropriate fine reference number attached to it, which makes reconciling the payment very challenging, especially if payments are made from person bank accounts, as opposed to Club Accounts. Clubs were reminded to use the appropriate reference numbers please!

6. Social Media (Tony Gee & Emma Vase)

a) Website

The Committee discussed an offer from Mr S Brown to support the website updates and publication of information. The offer was accepted and it was agreed that Miss N Browning be asked to forward the necessary log ins and training documents, so that progress could be made in updating and maintaining the website.

b) Facebook

Mrs Vase advised that she had taken over the responsibility of maintenance and administration of the Facebook sites from Miss N Browing and would be supporting Mr Gee; it was hoped that more posts would be placed, driving more traffic and interest from clubs and players.

7. Child Welfare Officer (John Thomas)

Mr Thomas updated the Committee that so far this season, 60 games had been observed, with a mixture of new teams (7), potential problem fixtures and requests from teams. On the whole, the behaviour of teams was good when Committee Members were in attendance, which is encouraging but it was noted that representation could not be at every game and teams needed to take responsibility for the behaviour and conduct of their own players, managers and spectators.

Mr Thomas also raised a discussion point around the correct size of pitch and goalposts being used by teams. Clubs were reminded of the correct sizes to be used, although it was noted that the guidance from The FA is around recommended sizes (not absolute) to ensure that games are played.

8. Sponsorship (Peter Brown / Ricardo Quieroz)

Mr Quieroz presented a Cup Final sponsorship to the Committee, highlighting different areas of potential sponsorship for the League. The Chairman thanked Mr Quieroz for his time preparing the document and asked the rest of the Committee to review the document and suggest as changes / amendments before the document is shared on a wider basis to try and attract sponsorship.
