REPORTS

1. Chairman (Peter Brown)

The Chairman again expressed his concern over the increasing amount of poor discipline that was occurring in CYFL fixtures. Although matters were being appropriately escalated and reported to the relevant County Football Associations, this did not appear to be a deterrent to clubs, and he welcomed any thoughts from people as to how these issues could be addressed to reduce them.

Rule Changes

Following discussions at the recent Full Council Meeting, the following suggestion regarding rule changes had been submitted by club:-

A couple of areas I would like to discuss changing in the constitution are:

Max number of players that can be signed during a season. Currently an u18 team in the league has 28 players signed on. I propose that a maximum of 20 players be allowed at any one time. If a club wants to exceed the 20 player limit they should be encouraged to put an additional team in the league.

The fine for playing a non-registered player or playing a player when ineligible should be increased from £30 to £50 per player, per game.

The manager should also receive a 3 match touch line ban. If the offence was a deliberate attempt to cheat.

Mark Webb (Barton Rovers Under 18)

The Committee thanked Mr Webb for his suggestions. Following discussions, the Committee agreed that although they did not support the suggestion relating to the reduction of players at Under 18 level, this could be put to member clubs for discussion and a vote at the AGM if the proposal could be seconded.

The second element relating to the change to the fine issued to clubs found guilty of fielding ineligible players would be considered provided it sat within the guidance given by The FA's Standard Code of Rules (Youth).

The third element is not within the control of the CYFL as discipline sanctions of this type would be handled by the County FA's if the offence was found proven.

3. Fixture Secretary (Tony Gee)

• Fixture Updates

The Fixture Secretary advised that currently he was working on completing the fixture schedule by Sunday 7th May, leaving just Cup / Plate / Shield / Trophy Finals for Sunday 14th March. Cup games were being squeezed in where possible, with midweek games likely through April to try and complete the league season before pitch availability was reduced.

Clubs were urged to be flexible with regards to kick off times and pitch locations to try and get games played as following the prolonged period of bad weather in January, a large number of games had been postponed and needed to be fitted in before the end of the season.

County Cup Fixtures

Mr Gee recorded his congratulations to the CYFL teams who had been successful in reaching the semi-finals of the Under 14 / 16 and 18 County Cup Competitions in Bedfordshire, whilst also noting that MK Warriors had successful reached the semi-final of the Berks & Bucks County Cup before being knocked out. The Committee endorsed these congratulations – well done to all.

Committee Pitch Walking (report as supplied by John Thomas)

Mr Thomas reported that Committee Members had so far attended 65 fixtures this season (around 5% of fixtures played), reporting back on behaviours observed and offering advice to clubs. To date of meeting, 7 out of the 10 new clubs to have joined the league for the 2022 / 23 season had been observed, with the remainder scheduled over the coming weeks.

Mr. Thomas reported that unfortunately, following reports of poor behaviour, 15 teams had been identified as requiring observation. The Committee discussed the logistics of arranging representation at future games for these teams over the coming weeks so that reports could be submitted at the next meeting.

4. Players Registrations Secretary (Emma Vase)

The Player Registration Secretary provided the below summary to illustrate the position at the time of the meeting.

A question was raised around the issuing of weekly discipline reports from the County FA's detailing those players and clubs under suspension to support leagues with monitoring participation. Previously these reports had been issued, but they have stopped and make things a lot harder for leagues to monitor effectively. It was agreed that Mrs. Vase would contact the Bedfordshire Football Association to enquire whether the information / reports could be re-instated.

The Committee discussed the registration / transfer deadline of 1st March and it was agreed that this would be circulated to clubs ahead of the date as a reminder as well as being posted on social media. Any exceptional requests received after the closing date will be reviewed on a case-by-case basis by the Committee and should be submitted in writing to the Player Registration Secretary for consideration.

The Player Registration Secretary advised that she would be reviewing the eligibility of players ahead of any cup / plate / shield / trophy semi-finals to ensure that all players had played the minimum number of fixtures to be eligible. Clubs were reminded that in accordance with League Rule 9 (Rules of Knock-out Cup and Subsidiary Cup Competitions –

page 86 of the handbook) for players to be eligible to play in Semi-Final or Final fixtures, they must have played a minimum of 3 games for that club in the CYFL in the current season.
